

The Heart of Texas Workforce Development Board, Inc. is committed to building a strong economic environment, growing industries, profitable businesses, skilled workers and thriving communities. Consistent with this commitment, the Heart of Texas Workforce Board plays a significant role in supporting the availability and affordability of high-quality early learning programs. Research shows that quality early learning environments create an important foundation for later success in school and life, thus making it an important, but often overlooked, part of the workforce development pipeline. Child care not only fuels our region's economy by helping parents work and/or complete their education/training, it also builds the workforce of our future.

Child Care Services (CCS) is a major program of Workforce Solutions. It is a dual-generation program supporting the health, safety and education of children and the economic stability of low-income families. CCS subsidizes the cost of child care for more than 2,100 children every day. In addition, the Board is responsible for implementing the state's Child Care Quality Rating and Improvement System (QRIS) known as the Texas Rising Star (TRS) Program. The goal of TRS is to assess and improve the level of quality in early learning programs and to broadly communicate the importance of quality child care and early experiences. Many of the Board's quality improvement activities improve early learning for all children enrolled in a Texas Rising Star facility, not just those receiving a subsidy. Currently, more than 90% of licensed child care providers work with CCS and more than 30% are Texas Rising Star certified. Increasing the number of TRS providers is a Board priority.

Research has found that participation in high-quality early learning programs has lasting benefits for children. There is longitudinal research demonstrating that there are intergenerational benefits too. Professor James Heckman conducted research on the landmark Perry Preschool Project that began in the 1960s. The original participants of the Perry Preschool Project are now in their 50s. The original participants, as parents, provided their own children with more attention and more resources and were more likely to live in a stable two-parent home. Professor Heckman also found that the <u>children</u>, of the original participants, had fewer suspensions, higher levels of education and employment, and lower levels of participation in crime compared with the control group. This suggests that participation in a high-quality early learning program may help to break the cycle of poverty for future generations. Our work with children, families and the child care industry moves us toward our goals of building a strong economic environment with skilled workers and thriving communities.

The Board's quality plan is organized into four overarching goals: (1) to increase the supply of quality child care, (2) to increase the professionalism of the child care workforce, (3) to support developmentally appropriate environments, and (4) to engage parents and community partners in early learning. These goals are used to guide the selection of the projects listed below.

Increase the Supply of Quality Child Care

Promote Texas Rising Star (TRS) Participation	Promote TRS to child care providers, parents, and the community. TRS is the Quality Rating and Improvement System (QRIS) in Texas. It is a systematic approach to assess, improve, and communicate the level of quality and in early and school-age care and education programs. CCS will work with Board staff to utilize promotional materials, marketing, and community outreach efforts to increase awareness of the importance of quality child care and the recognition of TRS. Support National Accreditation	Explore opportunities to support TRS providers interested in pursuing national accreditation.	Document efforts to promote national accreditation.		
Support PreK Partnerships	Explore opportunities to support partnerships between ISDs and Texas Rising Star providers.	Document efforts to raise awareness of partnerships and support collaborations.		

Increase the Professionalism of the Child Care Workforce

Invest in Strong Leadership & Business Management	TRS directors and those working toward TRS certification will have access to free and low-cost professional development in leadership and business management. A pilot project is available for a limited number of TRS providers interested in implementing an online shared services/back office solution funded by TWC.	Provide copies of outreach efforts, enrollment, training descriptions and evaluations, if available.
Advance the Knowledge and Skills of Teachers	CCS will offer high-quality and affordable professional development opportunities to early childhood teachers and directors. Information on available programs offering credentials or degrees in early childhood or related fields will be made available. Programs funds may be used to support post-secondary training in certain circumstances. Training and purchase of assessment tools to measure instructional and classroom quality is encouraged.	Track topics, training hours, numbers of participants, and certificates/degrees awarded. Infant & toddler training must be reported separately.
Offer Wage Supplements	A wage supplement may be offered for completing a certificate/degree, or continued employment at a TRS program after earning a certificate/degree, or for TRS certification. This is based on the availability of funding.	Report the names of recipients, employer, reason, and amount.
Promote the Texas Workforce Registry	The Texas Workforce Registry is a web-based database where early childhood professionals can store and access their education and employment history, as well as the professional development hours they have completed.	Report efforts to increase awareness and usage of registry. Report the number of users in in 2nd and 4th quarters.
Explore the CDA High School Apprenticeship	Learn about this project at Waco ISD and explore opportunities to support and/or enhance it.	Document meetings and/or visits with local partners.

Frog Street Curricula	Frog Street Curriculum is used by TRS providers, Waco ISD PreK, and EOAC's Head Start program since 2010. Frog Street offers an infant, toddler, and preschool curriculum that are provided to TRS providers. Classroom Materials and Equipment	Funds for the purchase of classroom materials, equipment, and outdoor learning environments may be provided to TRS centers or those working toward TRS as funding allows.
